Dear Councilmen:

On October 3, 2006 bids were received from four construction companies for a Fire Department Storage Building. The lowest bid was from the Tancor Corporation in the amount of \$48,600. A bid tabulation of all bidders is attached.

The Fire Department's current floor space and storage is at capacity. The storage building will be located behind Fire Station #3 and will provide heated storage for the water rescue and hazmat trailers, fire fighting foams, hose tester and other spare equipment. Moving this equipment to the new storage building will help reduce vehicle congestion within the stations.

Funds are currently budgeted in the Fire Department's Capital Outlay/Buildings and Additions account. Therefore, it is recommended the City Council approve the resolution directing the Purchasing Agent to issue a Purchase Order in the amount of \$48,600 to Tancor Corporation for the Fire Department Storage Building.
