The MASA state umpire staff will be conducting three MASA state umpire clinics in 2012. The clinics are scheduled from 9:00 a.m. to 4:00 p.m. Doors will open at 8:00 a.m. for sign-in, umpire registration, and equipment sales. The format will include registrants choice of 'breakout' sessions. Any umpire wishing to make themselves 'eligible to be considered' as an at-large umpire in 2012 will be required to attend one of the three MASA state clinics, or any ASA National Umpire School.

MASA district clinics will be conducted in various locations listed in this registration form. The district UICs and their staff will conduct free clinics in an effort to prepare local umpires for the upcoming softball season. We sincerely hope that you take advantage of these opportunities to improve your umpire skills. Contact the district UIC if you need more information.

MASA will be hosting an ASA National Umpire School in 2012. It will be held in Holland, MI on April 27 thru April 29, 2012. The school is designed for all umpire ability levels. The school includes 2 1/2 days of classroom and on field training sessions. Clinicians for the school will be ASA National Deputy staff member, Julie Johnson, and ASA Regional UIC Mike De Leo from Michigan, and Jerry Fick from Ohio. 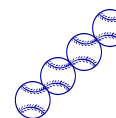
