\$25,000.01 TO \$50,000.00	\$252.00 FOR THE FIRST \$25,000.01 PLUS \$6.50 FOR EACH ADDITIONAL \$1,000.00 OR FRACTION THEREOF, TO AND INCLUDING \$50,000.00
\$50,000.01 TO \$100,000.00	\$414.50 FOR THE FIRST \$50,000.01 PLUS \$4.50 FOR EACH ADDITIONAL \$1,000.00 OR FRACTION THEREOF, TO AND INCLUDING \$100,000.00
\$100,000.01 TO \$500,000.00	\$639.50 FOR THE FIRST \$100,000.01 PLUS \$3.50 FOR EACH ADDITIONAL \$1,000.00 OR FRACTION THEREOF, TO AND INCLUDING \$500,000.00
